



#### **Objectives and sources**

- Monitoring 'overdose' deaths
  - Pillar 1: General mortality registers (national statistics)
  - Pillar 2: Special registers (forensic toxicology, police, providing more information on the drugs involved)
- Monitoring all causes of deaths among people who use drugs
  - Pillar 3: Linkage or longitudinal cohorts studies










## Sources used by the countries to monitor overdose deaths



- Most countries report data from both sources (general and special registers)→triangulation and validation
- Countries report data every year
- Many countries have set up a national working group





#### Festivals and DRD : findings from the survey October 2023

In your country, what is/are the source(s) of information about DRD and drug-related harms at big festivals? How many of these deaths have occurred over the last 2 years?



56 answers of which

- 44 with no/don't know/no information in the general mortality register/blank
- 12 with information available and data



Belgium	At Tomorrowland we collaborate with prevention teams, police, justice, festival authorities. This year, 2 deaths (one is not confirmed to be DRD). Since 2012, 6 deaths. For other festivals, no such collaboration		
Bulgaria	Last event related was in March, 2023 (Sofia elrow - kaos Garden). More than 10 hospitalizations (alcohol; alcohol + SCs) and 1 death (methcathinone overdose).		
Cyprus	None of the deaths occurred at big festivals.		
Czech Republic	No information on where the death occurred. We do have information from the annual final reports of the outreach harm reduction services that are present at these festival. From this, no report of fatal overdoses at festivals

#### Festivals and DRD : findings from the survey October 2023

- A range of sources can be used including forensic services, police, NGOs
- However, most countries report that their DRD information system could not flag these cases, if any
- Under-reporting an issue. But also a non-issue for some countries
- Rare reports of these deaths when system in place
  - (6 deaths in 12 years at Tomorrowland in Belgium (~400 000 attendees in 2023)



- Several experts report that there might have been some changes in practices in their countries (the questions in the report included the proportion of full scale autopsies or needle autopsies; the screening strategies; the equipments used; the list of drug routinely searched and of drugs that can be searched on request: whether an other laboratory can be asked to help for some specific analysis...)
- While we asked at the time about several fentanyl analogues, there was no question about e.g. nitazenes → to be followed up and updated




