Regulatory challenges	Prescription	Naloxone is provided at all branches of the Republican Centre for Addictive Disorders on prescription to patients leaving drug treatment. On the basis of the 'Resolution on naloxone provision in low-threshold services for the prevention of overdose' adopted in 2018, PWUD and their family members can obtain naloxone kits through a doctor's consultation at low-threshold agencies. Low-threshold agencies have to sign an agreement with a health care facility to allow their medical doctors to provide overdose response counselling and prescribe naloxone at the low-threshold agency.

Regulator	Administration	Allowed after counselling by medical doctor who prescribes naloxone.		
	Barriers	As naloxone is a prescription drug, low-threshold agencies have to close an agreement with a health facility, whose medical doctor issues the prescription, MDs are required to complete a 2-hour training course before prescribing naloxone. A 6-month pilot project conducted in low-threshold services in the cities Kaunas, Klaipeda and Alytus in 2019 assessed implementation barriers and found that the prescription requirement by medical doctor limits the availability in this setting.
